1 Deer Ticks (*Ixodes* sp.) have a complicated life cycle that ranges over a two year period and involves four life stages. Applications should be made in mid to late-spring to control larvae and nymphs that reside in the soil and leaf litter.

2 Imported Fire Ants: Control will be optimized by combining broadcast applications (of suitable EPA approved product) that will control foraging workers and newly mated fly-in queens with mound treatments that will control existing colonies.

The higher application rate may be required to control Ants, Centipedes, Chinch Bugs, Fleas, Imported Fire Ants, Millipedes, Mole Crickets & Ticks.
