† Remove patients before using. After treatment ventilate rooms for two hours before returning patients to rooms.

SHAKE WELL BEFORE USING

- OPEN** cabinets, cupboards, drawers, closets and doors in areas to be treated. **REMOVE** or cover exposed foods, dishes, utensils, food processing equipment and surfaces. **REMOVE** pets and birds, cover and turn off fish aquariums before spraying. Turn off air flow systems in aquariums. **COVER** waxed wood floors, waxed furniture and stereo or other plastic dust covers in the immediate area surrounding the fogger (newspaper may be used).
- CLOSE** outside doors and windows. **DO NOT** use more than one fogger per room. **DO NOT** use in small, enclosed spaces such as closets, cabinets or under counters or tables. Do not use in a room 5 ft x 5 ft or smaller; instead, allow fog to enter from other rooms. Turn off **ALL** ignition sources such as pilot lights (shut off gas valves), other open flames or running electrical appliances that cycle off and on (i.e., refrigerator, thermostats, etc.). Call your gas utility or management company if you need assistance with your pilot lights.
- Place a chair, table or stand in the center of the room to be fogged. Cover with several layers of newspaper, paper towels or plastic tarp.
- SHAKE CAN WELL.** Tilt sprayer **AWAY** from face (container sprays straight up). Press tab down in locked position.
- Set fogger on covered stand. Immediately leave treated area.
- Keep treated area closed for at least two hours. Before re-occupying area, open all doors and windows and allow treated area to air for 30 minutes.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

PESTICIDE STORAGE: Store in a cool, dry area away from heat or open flame and inaccessible to children.
