APPLY USING A ROTARY SPREADER - RECOMMENDED SPREADER SETTING IS 60%.

SNAKE SCRAM PROFESSIONAL™ is an excellent natural repellent for getting rid of snakes, including many poisonous species, which prefer to locate in stone piles, wood piles, around foundations, in gardens, flower beds & landscaping, and near pools. Avoid contact with or handling of snakes if you are unfamiliar with snake species and their proper handling. While most snakes are harmless, many varieties can strike and bite if surprised or disturbed by human activity. Also, several species in the United State are poisonous and can be harmful if they bite people or pets.

BEFORE APPLYING turn bag upside down and shake the closed bag vigorously.

APPLY by shaking granules in and around the area to be protected. The product should repel snakes immediately. If necessary, reapply as needed until snake activity ceases and no further snakes are observed.

REAPPLY Once repelling action has been established, reapply every two weeks. Reapply after heavy rains.

ALL SEASON USE! May be used in any climate or temperature.

DO NOT USE on food or feed crops. Do not apply directly to water.
